

# **Terms and Conditions of the CCC Promotion for Vacation DiscountClub Members “-20% on one selected product”**

## **I. Introductory provisions**

1. These Promotion Terms and Conditions define the rules of operation, conditions, scope, complaint procedure of the Promotion, rules of use and rights granted to persons participating in the Promotion (hereinafter also: “Promotion Terms and Conditions”).  
The discount is granted by MODIVO S.A. (Promotion Organizer) with its registered office in Polkowice, ul. Strefowa 6, 59-101 Polkowice (also the address for service), entered in the Register of Entrepreneurs kept by the District Court for Wrocław-Fabryczna in Wrocław, 9th Commercial Division of the National Court Register under number KRS 0000211692, NIP 6922200609, REGON 390716905, share capital PLN 7,702,589.40 fully paid, and by CCC Retail sp. z o.o. with its registered office in Polkowice, ul. Strefowa 6, 59-101 Polkowice, entered in the Register of Entrepreneurs of the National Court Register kept by the District Court for Wrocław-Fabryczna in Wrocław, 9th Commercial Division of the National Court Register under number 0001152606, NIP 5020128852, REGON 540769656, BDO 000676689, share capital PLN 5,000.00, e-mail address: info.pl@ccc.eu, contact phone number: (+48) 42 2144 222 (standard call charges according to the operator’s tariff) (hereinafter also: “CCC”).
2. The Promotion is conducted within the territory of the Republic of Poland in brick-and-mortar stores and in the Online Service available at: <https://ccc.eu/pl>, including via the CCC Mobile Application available on mobile devices at:

3. The Promotion cannot be combined with other promotions, except for the Large Family Card.
4. Vacation DiscountClub program members operated by Vacation Club 2 sp. z o.o. sp. k., who received a code as part of their participation, may take part in the Promotion.

## **II. Subject of the Promotion and conditions for participation**

1. The subject of the Promotion is the possibility for the Participant to benefit, under the rules set out in these Promotion Terms and Conditions, from the Promotion including a “-20% discount on one selected discounted or non-discounted product” (hereinafter also: “Subject of the Promotion”).
2. The Promotion applies to purchases made through the Online Service, including via the CCC Mobile Application, and in brick-and-mortar stores.

3. The Promotion cannot be combined with other promotions or promotional campaigns, except for the Large Family Card.
4. The Promotion is valid from 04 March 2026 to 31 May 2026 (hereinafter also: "Promotion Period").
5. The discount code is valid during the Promotion Period and may be used once within that period.
6. Participation in the Promotion is voluntary and free of charge (i.e., purchasing Products within the Promotion does not require any additional costs apart from payment of the Product price and delivery costs).
7. To participate in the Promotion, it is required to:
  - a) conclude a Product Sales Agreement via the Online Service, including via the CCC Mobile Application, or in one of the brick-and-mortar stores;
  - b) before concluding the Sales Agreement, enter the one-time discount code (received as part of Vacation DiscountClub participation) in the appropriate field indicated in the Online Service or provide the code to the Seller.
8. Within the Promotion, the price of one product in the cart will be reduced by 20%.
9. The Promotion does not cover (does not reduce) delivery costs, purchases of paper bags, or MODIVOclub GOLD services.
10. The Promotion benefit granted by the Organizer is not redeemable for cash, cannot be exchanged for any other means of payment, and is non-transferable.
11. The Participant has the right, but not the obligation, to use the Promotion when purchasing Products in the CCC Service. This does not exclude CCC's right to introduce an automatic participation mechanism in the Promotion for the Participant's benefit.

### **III. Complaints**

2. To expedite complaint processing, please provide name, contact details (e-mail or phone) and a description of the reasons for the complaint.
3. The Participant will be notified within 14 days electronically or in writing about the complaint decision and its resolution.

4. Complaints are handled by CCC in accordance with these Promotion Terms and Conditions.
5. Undamaged and unused Products purchased under the Promotion are subject to return according to the Return Policy.
6. Complaints regarding the Promotion benefit are processed in accordance with generally applicable law, including the Civil Code.

#### **IV. Final provisions**

2. CCC reserves the right to cancel the Promotion at any time without giving a reason. Information about cancellation will be published in the Online Service 3 days before termination.
